"There can be no sustainable development without human rights and the rule of law," the Secretary-General stated. Hundreds of policymakers and practitioners in the area of crime prevention and criminal justice, as well as experts from academia, representatives of intergovernmental and non-governmental organizations, specialized agencies and other UN entities, and media

NEWS FROM THE HUMAN RIGHTS BODIES

26 May 2015 / [UN Human Rights Expert States Human Rights Must be at Core of Future Development Financing](#): The UN Independent Expert on the effects of foreign debt and human rights, Juan Pablo Bohoslavsky, has said the Third International Conference on Financing for Development should endorse and reinforce a human rights-based approach to development. The appeal comes as States negotiate the outcome document of the Third International Conference on Financing for Development, to be held in Addis Ababa, Ethiopia, on 13-16 July 2015. "Human rights must be at the core of development financing to ensure that everybody can enjoy a decent life, free from hunger, and has access to education, health care, housing and drinking water," Mr. Bohoslavsky stressed. "The Conference should reiterate that the human being is the central subject of development and should be its active participant and beneficiary." The Independent Expert noted that private finance and businesses enterprises can make an important contribution to sustainable development. **Learn more [here](#). 4-15 May 2015 / [Libya, United States and Belarus Amongst Countries Assessed at the 22nd Session of the Universal Periodic Review Working Group](#) (*Shared, with thanks, by Asako Nozawa*): The 22nd session of the Universal Periodic Review Working Group took place from 4 to 15 May 2015 during which the following 14 States' human rights records were reviewed (in order of review): Belarus, Liberia, Malawi, Mongolia, Panama, Maldives, Andorra, Bulgaria, Honduras, United States, Marshall Islands, Croatia, Jamaica and Libya. Ambassador Joachim Ruecker of Germany, President of the Human Rights Council, stated in advance of the 22nd session "as we near the end of the second cycle of the Universal Periodic Review in 2016, the UPR increasingly serves as a yardstick allowing us to assess the progress achieved in realizing human rights, addressing challenges and finding solutions". **Read more [here](#).**

UN WORK IN FOCUS

20 April 2015 / [UN Participants at UN-Habitat Event ‘Human Rights in Cities and Cities for All’ Emphasize Vital Role of Human Rights Principles in Sustainable Urbanization](#): UN-Habitat, with

participation of OHCHR, hosted a session on ‘Human Rights in Cities and Cities for All’ at the 25th session of the Governing Council of UN-Habitat, 17-13 April 2015, which discussed human rights in the context of sustainable urbanization. The discussion centred on the human rights principles of participation, non-discrimination, equality, accountability to governance, empowerment of communities and which should guide the process of urbanization. Emelonye, a senior human rights advisor for OHCHR, stressed that the human rights-based approach needs to be applied to housing policies and plans, and that they must be inclusive and non-discriminatory. Alioune Badiane, Director of UN-Habitat’s Programme Division, emphasized the importance of affordability as one of the components of the right to adequate housing. **Read more [here](#). 15 April 2015 / [UN Hosts Health Leaders Working to Support Integration of Human Rights into Sexual and Reproductive Health Care](#): On Wednesday 15 April 2015, health leaders from around

the world convened at United Nations Headquarters, in New York, to highlight the need to ensure human rights are integrated into sexual and reproductive health care, including family planning. The meeting put focus on care that is non-discriminatory and aligned to the needs and desires of the community. Marleen Temmerman of the World Health Organization said that “access to reproductive health care – including family planning – is a human right. But the delivery of this care must also respect human rights standards, including the principle of non-discrimination.” Martha Icaza, UNFPA maternal health and intercultural expert in Panama, showcased UNFPA’s support of indigenous women in Panama who face high rates of maternal mortality due to cultural and communication barriers to sexual and reproductive health care.

Article, April 2015 / [Universal Rights, Differentiated Responsibilities: Safeguarding Human Rights Beyond Borders to Achieve the Sustainable Development Goals](#) / Center for Economic Rights and Third World Network: The authors examine one of the main fault lines in the post-2015 and Financing for Development (FFD) processes which is Common But Differentiated Responsibilities (CBDR). Developed and developing countries disagree over how far CBDR applies, with the G77 seeing it as broadly relevant across the agenda, while the majority of ‘Global North’ countries argue it is a narrow concept that only relates to the environment and climate change mitigation.
