## UNITED NATIONS NEWS

### 31 August 2015 / [UN Secretary-General: We Are Being Challenged to Strengthen Our Collective Resolve to Promote Peace and Security, Sustainable Development and Human Rights Around the World](#):

On 31 August 2015, the UN Secretary-General opened the Fourth World Conference of Speakers of Parliament of the Inter-Parliamentary Union (IPU) by urging legislators to help drive forward the new UN sustainable development agenda. He reaffirmed the important role that legislatures have in ensuring that the new development agenda is translated from the global to the national and emphasized that “we are being challenged to strengthen our collective resolve to promote peace and security, sustainable development and human rights around the world.” He told the IPU that, earlier this month, UN Member States took a bold step in this direction by concluding negotiations on the “ambitious and transformative” agenda for the next 15 years. In his remarks, the Secretary-General said that people “want full respect for their human rights and they are rightly demanding a greater say in the decisions that affect their lives,” and the 17 Sustainable Development Goals provide a roadmap for building a life of dignity for all. ## NEWS FROM THE HUMAN RIGHTS MECHANISMS

### 17 August-4 September 2015 / [The Committee on the Rights of Persons With Disabilities Holds 14th Session - 5 of the Sustainable Development Goals Are Specific to Persons With Disabilities](#):

The Committee on the Rights of Persons with Disabilities opened its 14<sup>th</sup> session, 17 August to 4

September, with the representative of the Office of the High Commissioner for Human Rights, James Heenan, emphasizing the role of human rights in the Sustainable Development Goals. He noted that the Post-2015 Outcome document included welcome human rights features and at its heart was the need to combat inequalities, discrimination and exclusion, including of persons with disabilities. María Soledad Cisternas Reyes, Chairperson of the Committee, noted that the Sustainable Development Goals included five objectives specific to persons with disabilities, such as the need for inclusive cities, transport and public space, the implementation

of resources, and capacity building. The Committee will discuss how to strengthen cooperation with United Nations bodies, specialized agencies, non-governmental organizations, including organizations of persons with disabilities and other competent bodies, in order to enhance the promotion and protection of the rights of persons with disabilities. **Read more [here](#).**

## UN WORK IN FOCUS

### **26 August 2015 / [UN Sets Up ‘Child-Friendly’ Space at Migrant Rest Area Near Former Yugoslav Republic of Macedonia Border Urging Authorities to Recognize the Rights of All Children](#) /**

**UNICEF and UNCHR:** The United Nations Children’s Fund has established a child-friendly space within the compounds of a migrant rest area, established by the Office of the UN High Commissioner for Refugees, with a mobile team to support women and children fleeing violence in their home countries and moving through the Former Yugoslav Republic of Macedonia. The UN is urging authorities to recognize and treat all migrant children – regardless of their legal status, religion or affiliation – first and foremost as children with rights, as set out in the UN Convention on the Rights of the Child. Furthermore, the Secretary-General’s report on international migration and development (A/68/190) urges an age- and gender-sensitive and rights-based approach to international migration. According to UNICEF, over the last month, the rate of migrants transiting through the country has increased to 1,500 to 2,000 per day – approximately 30 per cent of whom are women and children. Many are escaping conflict in their home countries of Syria, Iraq and Afghanistan. **Read more [here](#).
