21 April 2016 / [UN Urges Action on Sustainable Development to Create Pathways for Global ‘Transformation’ – As Multiple Crises Are Undermining Human Rights, Global Solidarity and the Concept of Leaving No One Behind](#): The President of the United Nations General Assembly,

Mogens Lykketoft, calls on the international community to take action on the new UN sustainable development agenda in order to begin a transformation for the benefit of all people and the planet, or risk failure that will be felt for generations to come. “The choice is yours,” said General Assembly President Mogens Lykketoft as he opened the High-Level Thematic Debate on Achieving the Sustainable Development Goals at UN Headquarters in New York. Mr. Lykketof emphasized that since the 2030 Agenda for Sustainable Development was adopted, world events have underlined the need for urgent action. Violent extremists have destroyed the lives of thousands around the world, while violent conflicts are threatening the lives of millions. In addition, an inadequate response to a global humanitarian and refugee crisis is undermining human rights, global solidarity and the concept of leaving no one behind, he said. The 2030 Agenda along with the recently signed Paris climate accord provide world leaders with a “solid framework” to address the root causes of such crises, the General Assembly President said. “But this will only happen if they are implemented with urgency; if we build on the foundations laid by the MDGs and if we manage the opportunities before us for the benefit of all,” he stressed. **Read more [here](#). 24 March 2016 / [Human Rights Council Concludes 31st Session After Adopting 37 Resolutions, 2 Decisions and One Presidential Statement](#): The Human Rights Council concluded its 31st regular session after adopting 40 texts – 37 resolutions, two decisions and one Presidential Statement – on a wide range of issues, as well as its report for the session. Among the resolutions adopted were those on: the promotion and protection of human rights in the context of peaceful protests which calls upon States to promote a safe and enabling environment for individuals and

groups to exercise their rights to freedom of peaceful assembly (A/HRC/31/L.21); the fulfilment of economic, social and cultural rights (A/HRC/31/L.7/Rev.1); the right to food (A/HRC/31/L.14); adequate housing as a component of the right to an adequate standard of living, and the right to non-discrimination (A/HRC/31/L.11); protection of human rights and fundamental freedoms while countering terrorism (A/HRC/31/L.3); the rights of persons belonging to national or ethnic, religious and linguistic minorities (A/HRC/31/L.18); freedom of religion or belief (A.HRC/31/L.35); and, human rights and the environment - taking into account human rights obligations and commitments relating to the enjoyment of a safe, clean, healthy and sustainable environment in the implementation of the Sustainable Development Goals (A/HRC/31/L.10). In another resolution, the Council called upon States to take all measures necessary to ensure the rights and safety of human rights defenders, including those working towards the realization of economic, social and cultural rights (A/HRC/31/L.28). **Read more [here](#). 24 March 2016 / [UN Commission on the Status of Women Ends with Agreement on Foundations to Accelerate Action](#):

The 60th session of the United Nations Commission on the Status of Women (CSW60), an intergovernmental body dedicated to the promotion of gender equality and the empowerment of women, concluded with UN Member States committing to “gender-responsive” actions with stronger laws, policies and institutions, better data and scaled-up financing. It was acknowledged that progress on the Sustainable Development Goals (SDGs) at the heart of 2030 Agenda for Sustainable Development will not be possible without gender equality and the empowerment of all women and girls. The agreed conclusions urge a comprehensive approach to implementing all 17 SDGs through thorough integration of gender perspectives across all government policies and programmes. In a press release by UN Women at the conclusion of CSW60 it was stressed that

eliminating all forms of gender-based discrimination depends on effective laws and policies and the removal of any statutes still permitting discrimination, adding that temporary special measures may be required to guarantee that women and girls can obtain justice for human rights violations. **Read more [here](#). 24 March 2016 / [‘Without Stories, There is Silence’ – Women Speak Up at the UN About Violence and Disability](#):

was featured during the CSW60. The exhibition “Silent Tears” is a storytelling platform for women with disabilities who have been subjected to violence and women who have acquired disabilities as a result of violence. The Special Rapporteur on the rights of persons with disabilities, Catalina Devandas Aquilar, stated “It’s important to remind women with disabilities that they have to be proud and they need to continue to be strong and to fight for their rights.” She added that the UN is doing a great deal to

increase attention on these human rights, especially since the adoption of the Convention on the Rights of Persons with Disabilities by the General Assembly in 2006. **The complete story with excerpts from the participants of the exhibition is available [here](#).**

24 March 2016 / [UN Chief Urges States to Promote Right to Truth and Justice](#): Observing International Day for the right to the truth, United Nations Secretary-General Ban Ki-moon urged States to adopt measures to promote truth, justice and reparations for victims of human rights violations, which is so crucial to ensuring that gross human rights violations are not repeated. In a message for the Day, Mr. Ban said that “across the world, every victim has the right to know the truth about violations that affected her or him.” He went on to say “the truth also has to be told for the benefit of all people and communities as a vital safeguard against the recurrence of violations. The right to the truth is closely linked to the right to justice.” To advance this effort, the UN supports fact-finding missions, commissions of inquiry, mapping exercises, and truth commissions, which document human rights violations and make recommendations to ensure accountability, reconciliation, and other reforms, he said, noting that from Colombia to Tunisia, from Mali to Sri Lanka, from Nepal to South Sudan, the UN has advocated for inclusive and genuine consultations with victims and affected groups, especially women, girls and those who are far too often excluded and marginalized. **Read more [here](#). NEWS FROM THE HUMAN RIGHTS MECHANISMS

22 April 2016 / [Committee on the Rights of Migrant Workers Closes 24th Session](#): The Committee on the Protection of the Rights of All Migrant Workers and Members of Their Families (CMW) concluded its 24th session after adopting its concluding observations and recommendations on the reports of Mauritania, Lesotho, Senegal and Turkey. During the session, the Committee adopted two statements on cooperation with national institutions and on the recent tragedy in the Mediterranean Sea. It also adopted the Guidelines against intimidation or reprisals, the “San José Guidelines,” and appointed Ms. Dzumhur as Rapporteur on reprisals. The Committee held a meeting with representatives of the United Nations Children’s Fund (UNICEF) on its General Comment on children in the context of migration. **Read more [here](#). 22 April 2016 / [Climate Change: UN Expert Welcomes Historic Paris Agreement but Calls on States to Scale Up Efforts](#):

The UN Special Rapporteur on human rights and the environment John Knox said in a statement on the 22 April signing of the Paris Climate Agreement is “a historic step towards ensuring that the fight against climate change takes into account its effects on human rights.” He urged States to seize the moment to show their full commitment to keeping the increase in global average temperature well below 2°Celsius. The United Nations Environment Programme, even full implementation of the Governments’ Intended Nationally Determined Contributions (INDCs) would lead to emission levels in 2030 that will likely cause a global average temperature increase of well over 2°C, and quite possibly over 3°C. Therefore, the expert stressed, “even if they meet their current commitments, States will not satisfy their human rights obligations.” He underscored that “from a human rights perspective, it is necessary not only to implement the current intended contributions, but also to strengthen those contributions to meet the target set out in article 2 of the Paris Agreement.” **Read more [here](#).**

21 April 2016 / [Committee on the Rights of Persons with Disabilities Concludes 15th Session](#):

The Committee on the Rights of Persons with Disabilities concluded its 15th session after adopting its concluding observations and recommendations on the reports of Chile, Lithuania, Portugal, Serbia, Slovakia, Thailand and Uganda on how they implement the provisions of the Convention on the Rights of Persons with Disabilities. During the session, in addition to considering country reports, the Committee continued its discussion on the draft General Comment 3 on article 6 of the Convention, which deals with women and girls with disabilities. The Committee also marked the tenth anniversary of the Convention, on 19 April, by hearing statements by the representatives of several States parties, United Nations bodies and civil society organizations, as well as testimonials by civil society on the impact of the Convention on persons with disabilities. **Read more [here](#). 31 March 2016 / [Human Rights Committee Closes 116th Session](#):

On 31 March the Human Rights Committee concluded its one hundred and sixteenth session after adopting concluding observations and recommendations on the reports of South Africa, Namibia, Sweden, New Zealand, Slovenia, Costa Rica and Rwanda. During the session the Committee heard progress reports from its Special Rapporteurs on follow-up to concluding observations and on follow-up to views. The Committee also discussed its methods of work, as well as a number of individual communications in closed meetings. The Committee continued its discussion on a draft General Comment on Article 6 of the International Covenant on Civil and Political Rights, on the right to life. **Read more [here](#). 24 March 2016 / [Human Rights Council Adopts the UPR Outcomes of 14 Countries and the Decision to Commence the Third Cycle of UPR in April/May 2017](#):

During its 31st session, the Human Rights Council adopted the UPR outcome reports of the following 14 countries reviewed in the 23rd UPR Working Group session in November 2015: (Australia, Austria, Georgia, Lebanon,

Mauritania, Micronesia, Myanmar, Nauru, Nepal, Oman, Rwanda, Saint Kitts and Nevis, Saint Lucia, and Sao Tome and Principe). With the adoption of these outcomes by the Human Rights Council, 154 countries have now completed their reviews in the UPR 2nd cycle. During a general debate on the UPR, the importance of capacity building and technical and financial assistance provided by the Office of the High Commissioner for Human Rights was also emphasized. The practice of mid-term reports was welcomed. 4 March 2016 / [Committee on Economic, Social and Cultural Rights Concludes 57th Session](#): The Committee on Economic, Social and Cultural Rights (CESCR) closed its 57th session after adopting its concluding observations and recommendations on reports of Namibia, Canada and Kenya on their implementation of the International Covenant on Economic, Social and Cultural Rights. The Committee also adopted two General Comments: the General Comment No. 22 on the right to sexual and reproductive health (mentioned in more detail below), and General Comment No. 23 on the right to just and favourable conditions of work. In the course of the session the Committee Chairperson, Waleed Sadi, discussed how the Committee had prepared an outline of the General Comment on human rights, the environment and development, as well as two substantive statements - on public debts and on the refugee/mixed migration flows. The Committee had also addressed matters related to the anniversary of the two Covenants and the treaty body strengthening process. **Read more [here](#). 4 March 2016 / [UN Experts Urge Respect for the Rights of Rural Women and Recognize their Vital Role in Development – New CEDAW General Recommendation No. 34 on the Rights of Rural Women](#): Ahead of International Women's Day, which was held on Tuesday 8 March, the Committee on the Elimination of Discrimination against Women (CEDAW) called for a focus on rural women and girls, and effective implementation of the Sustainable Development Goals (SDGs), many of which have an impact on the situation of rural women. In its new General Recommendation, No. 23, on the rights of rural women CEDAW recognizes that rural women continue to face systematic and persistent barriers to the full enjoyment of their human rights and that conditions, in many cases, have deteriorated. The experts stress the need to protect and promote the rights of rural women and girls in accordance with Article 14 of the Convention. Article 14 is the only provision in an international human rights treaty that specifically pertains to rural women. CEDAW highlights the specific obligations of States parties in recognizing, promoting and protecting their rights. **Read more [here](#). 4 March 2016 / [“Due To Stigma We Are Mostly Invisible” Says UN Special Rapporteur on the Rights of Persons with Disabilities](#): The UN Special Rapporteur on the rights of persons with disabilities, Catalina Devandas Aguilar, presented her report at the Human Rights Council on the participation of people with disabilities in public life and decision-making. She states that “people

with disabilities constitute at least 15 percent of the world population – the equivalent of the entire population of the Americas. Due to stigma we are mostly invisible, we rarely occupy positions in governments, and we are normally not consulted about policy-making, even when the issue directly affects us.” The human rights expert recalls that the Convention on the Rights of Persons with Disabilities, which has been ratified by 162 countries, obliges States to consult closely with persons with disabilities, recognizing their right to participate in all areas of public decision-making, not just those related to their disabilities. However, according to the Special Rapporteur this is still a distant dream. “It goes against the idea of ‘leaving no one behind’. At this rate we won’t meet the new Sustainable Development Goals unless people with disabilities are treated differently,” she warned. **Read more [here](#).**

UN WORK IN FOCUS

“We Are All Human Rights Defenders” – UNAIDS Launches Annual Human Rights Defenders Awards / UNAIDS (*Shared, with thanks, by Luisa Cabal*): UNAIDS launched an internal

awareness, capacity and commitment-building initiative titled “We are all human rights defenders,” in order to inspire, engage, reward, and support UNAIDS staff members to be champions for human rights in the HIV response. The award also seeks to create awareness and encourage commitment and action by all UNAIDS staff members to end HIV-related discrimination. The initiative has several activities, which include providing opportunities for learning and capacity building for UNAIDS staff



members on advancing zero discrimination and human rights and support cross fertilization and experience-sharing within UNAIDS on best approaches for preventing and handling HIV-related human rights issues, including crises impacting the HIV response. Steve Kraus, Director of UNAIDS Regional Support Team for Asia and the Pacific, and a recipient from one of the five teams who received the award for their work in 2015, stated “if you work for the United Nations, your DNA has to be human rights. There is no other institution in the world that provides a better platform to defend the rights of all people most particularly those without a voice.
